I am writing regarding reports that the U.S. Department of Homeland Security and U.S. Immigration and Customs Enforcement are leasing an office space at 1000 Westlakes Drive, Berywn, Pennsylvania .

As a state Senator representing the 19th District, which includes Tredyffrin Township and the Westlakes Campus, my office has received dozens of calls and e-mails from many constituents who are very concerned, frustrated, and angered by the idea of ICE expanding in our community.


Like them, I believe that the way ICE is currently operating and being used by the federal government is not making our communities safer. Given the ongoing political firestorm caused by ICE deploying anonymous/masked agents, military-style equipment and tactics, and indiscriminately detaining people of color, I imagine that you, too, have received calls, complaints, questions, and inquiries.

I understand the need for companies to attract clients and serve customers. However, it is also important for businesses responsive to community concerns. Given the continued human rights concerns and overall atmosphere for fear, intimidation, harassment, and violence that ICE is bringing to communities across our nation, I ask that you respectfully reconsider this agreement.

Like many Pennsylvanians and our Governor, I strongly believe that ICE detention centers do not belong in the Commonwealth, and we do not want them here. While reports indicate that the Westlakes location will house analysts, lawyers, and other backroom or administrative functions, my constituents and I know that those operations only serve to support the current work of ICE, which, at this point, is wrong, inhumane, and downright un-American.

Again, to protect your reputation and that of your clients, customers, and other leaseholders, especially those on the Westlakes campus, I respectfully ask you to reconsider this lease agreement. Please take the opportunity to reflect on how doing business with ICE, as it is currently operating, could impact your company and its standing in our community.
